Dear Friends,

Greetings and best wishes from Asian Shooting Confederation (ASC) Headquarters, Kuwait.

We would like to inform all member federations that the ASC Executive Committee have developed distribution program that was approved by ISSF for Asian Continental Quota Places for Paris Olympic Games 2024. Moreover, the IOC approved the Olympic Qualification Criteria for Paris 2024 that states each NOC is eligible for a maximum of (2) quota places per event per gender and One (1) NOC can obtain one (1) quota place in any of the individual events at one (1) designated ASC Championship.

In view of the above, Asian Continental Quota Places for Paris Olympic Games 2024 will be distributed as follows:

- a) 24 continental quota places will be distributed in 15th Asian Shooting Championship 2023 in Changwon, KOR. (Total of Twelve (12) events and Two (2) quota places available per event)
- b) 8 continental quota places will be distributed in Asian Shotgun Championship 2024. (Total of Four (4) events and Two (2) quota places available per event)
- c) 16 continental quota places will be distributed in Asian Rifle / Pistol Championship 2024. (Total of Eight (8) events and Two (2) quota places available per event)

Therefore, ASC is inviting its member federations to forward applications for hosting the Asian Shotgun Championship 2024 and Asian Rifle / Pistol Championship 2024, proposed to be organized in the months of February and March 2024 respectively but in all events by no later than the beginning of May 2024.
